**1. BASIS OF LATERAL ENTRY ADMISSION:**

It is intended to fill the vacant seats available at the beginning of 2<sup>nd</sup> year for the B.Tech (Naval Architecture & Ocean Engineering) henceforth referred to as **B.Tech (NAOE)** and B.Tech (Naval Architecture & Ship Building) henceforth referred to as **B.Tech (NASB)** programs being conducted at IMU Visakhapatnam campus for **Academic Year 2025-26 through Lateral Entry (admission into 2<sup>nd</sup> year). The duration of the above academic programs will be three academic years consisting of six semesters of course work.**

Indian Maritime University invites applications from eligible candidates fulfilling the educational and other eligibility criteria for the above mentioned UG programs Lateral Entry admissions at its Visakhapatnam campus. The details are as given below:

**Last date for receipt of applications: 5<sup>th</sup> July 2025**

**The Lateral Entry admissions shall be made by way of conducting an Entrance Test (Physical mode by way of pen and paper. No online test.)(Subjected to condition that number of valid applications after scrutiny being more than the total number of vacancies).**

- a. The question paper of the Entrance Test will comprise of a total of 120 MCQ's covering the following subjects each with 30 questions of 1 mark each totalling to 120 marks :
- b. Duration of test shall be **2 hours**.
- c. **There will be negative marking of 0.25 marks for each wrong answer.**

**Kindly note: In the event of the number of valid applications being less than or equal to the number of total vacant seats, IMU may adopt other means to arrive at the merit list for subsequent processing.**

**2. Age Limit:**

- i) There is **no minimum age limit** criteria for admission into the above programs.
- ii) Maximum age:
  - For Male : Gen-25 years, OBC (NCL)-28 years, SC/ST-30 years.
  - For Female : Gen -27 years, OBC (NCL)-30 years, SC/ST-32 years.
  - For Others (Transgender): 2 years more than the age for the above mentioned female categories.

**The reference date for calculation of the age will be from the date of commencement of the Academic Session (i.e. 01-08-2025).**

**3. Educational Qualifications**

- a. 4-years Diploma in Ship Building Engineering with at least 60% marks overall and should have completed the diploma within the stipulated period of 4 years **AND** a minimum of 50% marks in English subject in 10<sup>th</sup> / 12<sup>th</sup> examination.  
Or
- b. 3-years Diploma in **Mechanical / Civil** Engineering from any institute approved by AICTE with at least 60% marks overall and should have completed the diploma within the stipulated period of 3 years **AND** a minimum of 50% marks in English subject in 10<sup>th</sup> / 12<sup>th</sup> examination.  
Or
- c. 3-years Diploma in Naval Architecture and Offshore Engineering with at least 60% marks overall and should have completed the diploma within the stipulated period of 3 years **AND** a minimum of 50% marks in English subject in 10<sup>th</sup> / 12<sup>th</sup> examination.  
Or
- d. 3-years B.Sc. (Ship Building & Repair) with at least 60% marks overall and should have completed the degree within the stipulated period of 3 years **AND** a minimum of 50% marks in English subject in 10<sup>th</sup> / 12<sup>th</sup> examination.
- e. **Relaxation of for SC/ST candidates only (if any):** There will be a 5% relaxation in eligibility marks. **However, it will not apply to English marks.**
- f. **Eligibility - Medical fitness:** All candidates who get selected will have to submit a Physical Fitness Certificate from a Registered Medical Practitioner at the time of Certificate verification.

**5c. APPLICATION FEES AMOUNT DETAILS:**

An Application Fee for **Rs.1000/-** for all other candidates and **Rs.700/-** for SC/ST candidates only to be paid along with the submission of filled in application in the form of **Demand Draft** payable at **Visakhapatnam** drawn in favour of **Indian Maritime University, Visakhapatnam campus.**

**Applications without the appropriate DD will be rejected.**

**b. The Entrance Test shall be by way of physical pen & paper mode. There is no online test provision.**

**c. The candidates will be required to report at IMU, Visakhapatnam Campus for appearing the above Entrance Test at their own expenses of traveling and boarding. IMU shall not reimburse any such amount incurred by the candidate/s.**

8. **Subject to the candidate being placed in the successful list of merit in the Entrance Test or otherwise** for the above lateral entry programs, the following process shall be subsequently involved:

**a. Successful candidates shall be intimated by way of registered email and/or telephonically of their success.**

**b. Verification of certificates: On an announced date, candidates to be physically present and should produce in original the following certificates for verification:**

**I. SSC / 10<sup>th</sup> Standard Mark sheet ( for proof of date of birth)**

**II. Provisional Degree Certificate / Diploma Certificate as applicable**

**III. Courses Completion Certificate (if provisional certificate is not issued)**

**IV. Statement of Marks of all semesters / academic years.**

**V. Certificate of category in case of SC/ST/OBC (NCL)/Gen-EWS.**

**Kindly note the OBC (NCL) and the GEN-EWS certificate should be as per the format given. No other format shall be accepted.**

- A. After verification of certificates, finding all data to be correct, and payment of the fees as mentioned in below point (9) the candidate will be issued Provisional Admission letter.**
- B. IMU reserves the right to allocate any leftover seats in any category to waitlisted candidates in that category or to any other remaining categories. In case of any dispute, the decision of IMU shall be final.**

C. The finally selected candidates will have to report at IMU Visakhapatnam Campus and register for the 3<sup>rd</sup> semester in the academic session 2025-26. The fee payment details are as mentioned in (9) below.

D. **Choice of branch: The candidate's preference of choice of branch i.e. B.Tech (NAOE) or B.Tech (NASB) shall be based on the merit rank in the conducted Entrance Test and other reservation criteria as applicable. In case of tie of marks in the Entrance Test, IMU may adopt other relevant criteria as tie-breaker/s. In this regard the decision of IMU shall be final and binding and the student has to abide by it.**

#### 9. **Fee Particulars:**

The candidates are instructed to pay the following fee at the time of reporting to IMU, Visakhapatnam campus for formal registration:

- I. An Admission Registration/Counselling fee of **Rs.10, 000/-** (Rupees Ten Thousand only) through a Demand Draft in favour of **Indian Maritime University**, payable at **Visakhapatnam**.
- II. **Rs.30,000/-** (Rupees Thirty Thousand only) towards Programme Fee through Demand Draft in favour of **Indian Maritime University**, payable at **Visakhapatnam**.
- III. The Semester fee of **Rs.1,22,500/-** (Rupees One Lakh Twenty Two Thousand Five Hundred Only) should be paid at the campus for 3<sup>rd</sup> semester fee on the day of registration through a Demand Draft in favour of **Indian Maritime University**, payable at **Visakhapatnam**.
- IV. An amount of **Rs.30,000/-** (Rupees Thirty Thousand only) should be paid at the campus as Caution Deposit (refundable) through a Demand Draft in favour of Indian Maritime University, payable at **Visakhapatnam**.
- V. Balance fee for 2<sup>nd</sup> year (i.e. 4<sup>th</sup> semester), to be paid in the beginning of the fourth semester, approximately sometime in January 2026.
