Indian Maritime University invites sealed quotations for supply of branded packaged drinking water Jar / Bottles (Mineral Water with latest BIS specifications) for their campus situated in Gandhigram, Visakhapatnam-5 for a period of one year. The terms and conditions for Annual contract for Supply of Packaged Mineral Drinking Water in 20 litre bottles for a period of one year are as follows:

2. Tentative requirement:

The successful tenderer is required to supply tentatively 600 bottles per calendar month during the stay of students in hostel for around nine months and during vacations of around three months 120 bottles per calendar month may be required. It is a must that the Tenderers are to comply with the chemical parameters of the packaged mineral drinking water that the Total Dissolved Solids in any case should not exceed 50 PPM or mg / liter. The water manufacturing / processing unit shall have valid food safety clearance certificate obtained from Government of Andhra Pradesh Food Safety department and an attested copy must be enclosed with the quotation. The tenderer being an agency / supplier / distributor other than the Manufacturing Company has to submit the valid certificate as proof to supply the Packaged Mineral Drinking Water failing which the quotation will be summarily rejected.

3. Procedure for submitting:

The bidder shall submit the sealed quotation as per Annexure 'A' in a sealed cover envelope duly superscribed with the words "Quotation for supply of branded packaged drinking water Jar / Bottles (Mineral water with latest BIS specifications) at IMU, Visakhapatnam campus addressed to The Director, Indian Maritime University, Gandhigram, Visakhapatnam so as to reach on or before Monday, the 20th March 2017.

- Self attested copy of PAN number.
- 2. Self attested copy of VAT / TIN registration certificate
- 5. Terms and conditions:

- xiii. In case packaged drinking water supplied by the Vendor is not as per BIS specification / standard, the same shall be rejected and no payment will be made for the same by IMUV.

IMUV also reserves the right to renew or extend the contract for such period(s) as it may deem necessary, taking into account, of course, the satisfactory services rendered by the successful bidder during previous year.
