4 PROJECT OVERVIEW

IMU Visakhapatnam Campus is conducting a two year full time Master's Program in Dredging & Harbour Enginnering. Students who have completed thier undergraduate program in Civil / Mechanical/ Marine/ Naval Architecture & Ocean Engineering & Aeronautical engineering are eligible to take this sepcialised course.

IMU Visakhapatnam Campus intends to use Computer based educational packages which are readily available, to students of Master's program (M.Tech) in Dredging & Harbour Engineering so as to complement the class room lectures on various aspects of dredging. The educational packages are intended to cover the general dredging aspects along with details of Cutter Suction Dredgers (CSD).

Category 1

Category 2

The responders should have on their own developed computer based educational packages / simulators in the area of dredging and be in the business of conducting training in the area of dredging for the last 8 years.

This RFI is meant to solicit information on computer based educational products which can readily be used for the Masters Program in Dredging and Harbour Engineering and especially related to Dredging. The Various topics which are intended to be covered by such packages include

7.1 Overview of Functional Requirements

The Functional Requirements for The Computer based educational pacakages should include but not limited to:

 - ix. Design considerations creating and restoring wetlands Etc
 - b. Basic dredging procedures including planning, working methods, project production calculation, project cost calculation, project reporting & monitoring.

 - a. Dredge pump characteristics, pump cavitation
 - i. Drive characteristics
 - ii. Dynamic effects of pump and drives
 - iii. Pipeline system characteristics
 - iv. Interaction between pump, drive and pipeline
 - v. Influence of solid particles on pump and slurry processes
 - vi. Dynamic effects in the pump and pipeline systems
 - b. Cutter Suction Dredging

7.2 Overview of Performance Requirements

The Computer based educational / learning pacakges should be so designed that the learner can become acquainted with the complete dredging and discharging process, including barge, ladder, cutter head, main spud and spud carrier movements, as well as auxiliary spud, anchor booms and anchor handling, including the accompanying motors and hydraulic drive systems. They should be able to learn about the excavation process and the interaction between cutter head and soil, caving in and breaching of the soil, the mixture transport chain and the influence of tide, current, waves and weather. They should be able to discover how to operate and debug the vessel's power and auxiliary systems and about the specifics of those systems.

The laearners should be able to plan a dredging operation starting with site survey including surveying techniques, preperation of charts, dredging quantity estimations, selection of dredgers, production calculations, project monitoring and reporting.

7.3 Overview of Availability Requirements

It is intended that the computer based package is avalable to the students at any time. The package must support atleast 10 users using the packages simultanously.

7.4 Overview of Technical Requirements

The computer based educational packages may be designed in the form of standalone computer systems accompanied with learning material, instructions, Q&A sessions, videos, 3D interactive images, simulations, case studies etc. The systems should be able to be accessed from desk top computer / dedicated workstations with single / multiple screens based on the design. Audio instructions/ descriptions should preferably be available. The packages should be accompanied with standard lessons in form of audio instructions along with video imagery and text covering all aspects for dredging and in using cutter suction dredgers.

The package may also be designed in the form of a simulator with a separate instructor station in which case the students will have the option of using this one at a time along with an instructor station.
