Indian Maritime University, Visakhapatnam Campus, Visakhapatnam invites sealed quotations for the internal wall paintings of the Students Hostel of Indian Maritime University, Visakhapatnam Campus as per the following specifications.

- a) Repairing of Crack Walls with Scrapping/Cleaning/Removing of ink marks on walls
 - b)
 - i) Painting with one coat of cement primary wherever necessary and two coats of Acrylic Distemper for walls or 03 (three) coats of acrylic distemper (including all Cup-boards inside and outside);
 - ii) Scrapping and cleaning of wooden Doors and window doors & grills and painting 01 or 2 coats of enamel paint with approved colors.
 - iii) One coat of white distemper or Birla white coat for ceiling area of the entire Hostel
 - c) Cleaning of Floors and other areas are to be cleaned after painting.
1. The time allowed for carrying out the work will be **Five** weeks from the date of work order to commence the work.
 2. The amount of Earnest Money Deposit of Rs.10,000-00 and shall be paid in the form of Demand Draft drawn on any Nationalized / Schedule Bank in favour of Indian Maritime University, Visakhapatnam Campus. The Demand Draft should be enclosed to the Quotation and should not be sent separately.
 3. The quotation shall include all taxes applicable.
 4. The quotation must be submitted in the Pro-forma given at Annexure to this document.
 5. The firms must submit the following documents along with the quotation
 - a) Documentary proof of PAN Card
 - b) Documentary proof of Service Tax Registration issued by the concerned Department
 6. The competent authority does not bind himself to accept the lowest or any other tender and reserves to himself the authority to reject any or all the bids received without the assignment of any reason.
 7. The competent authority reserves to himself the right of accepting the whole or any part of the bid and the bidder shall be bound to perform the same at the rate quoted.

8. The Contractor shall responsible for Safety and Security of the personnel deployed for the work and should ensure that the safety appliances such as safety belt, helmet etc., are to be used at the time of executing the work.
9. During the course of execution of work, the damage / loss incurred to the property shall be to the account of the Contractor.
9. Bidders are advised to inspect and examine the site and its surroundings on all working days from 1000 Hrs. to 0500 Hrs. (except Saturday and Sunday)
10. The quotations received without complying with any of the above is liable for rejection without assigning any reason. In this connection the decision of the University shall be final and binding.
11. TDS will be deducted at source at the applicable rates.

The sealed quotations complete in all respects duly super scribed as "Quotation for Wall Paintings" with quotation reference and due date.
