It is proposed to fill the seats available for the B Tech (Naval Architecture & Ocean Engineering) program being conducted at Visakhapatnam **campus for Academic Year 2020-21 through lateral entry scheme (admission into 2<sup>nd</sup> year).**

Indian Maritime University invites applications from eligible candidates fulfilling the educational and other eligibility criteria for the U G program at its Visakhapatnam campus through the lateral entry scheme.

## 1. Age Limit:

- i) Minimum age 18 years
- ii) Maximum age:

For Male : Gen-26 years, OBC (NCL)-29 years, SC/ST – 31 years  
For Female : Gen -28 years, OBC (NCL)-31 years, SC/ST-33 years.

The reference date for calculation of the age will be from the date of commencement of the Academic Session.

## 2. Educational Qualifications

- a. A Diploma in Ship Building Engineering from Institute of Ship Building Technology (ISBT), Goa with at least 60% marks overall and should have completed the diploma within the stipulated period of 4 years.

Or

- b. A Diploma in Mechanical / Civil Engineering from any institute approved by AICTE with at least 60% marks overall and should have completed the diploma within the stipulated period of 3 years.

Or

- c. 3-year Diploma in Naval Architecture and Offshore Engineering from the AMET University, Chennai with at least 60% marks overall and should have completed the diploma within the stipulated period of 3 years.

- ## 3. No. of seats vacant:
- Total No of seats vacant are 11 and admissions will be made in the order of merit based on aggregate percentage of marks in their respective diploma.

The applications received will be scrutinised category wise based on the age and qualifying educational criterion and shortlisted based on merit only. The list of shortlisted and waitlist candidates will be put up in the website [www.imuv.edu.in](http://www.imuv.edu.in) . The shortlisted candidates will also be intimated by e-mail.

- B. The shortlisted candidates will be required to report at IMU, Visakhapatnam Campus for verification of certificates & counselling. The date and time of reporting will be intimated in due course of time. The following certificates should be produced in original at the time of counselling.
- I. SSC / 10<sup>th</sup> Standard Mark sheet ( for proof of date of birth)
  - II. Provisional Certificate / Degree or Diploma Certificate as applicable
  - III. Course Completion Certificate (if provisional certificate is not issued)
  - IV. Statement of Marks of all Semester / academic years.
- C. After verification of certificates, the candidate will be issued the admission letter.
- D. IMU reserves the right to allocate any leftover seats in any category to waitlisted candidates in that category or to any other remaining categories.
- E. The Selected candidates will have to report at IMU, Visakhapatnam Campus and register for the **3<sup>rd</sup> semester**.

5. **Fee Particulars:**

- A. **An application Fee for Rs.1000** for General candidates and **Rs.700** for schedule Caste /Scheduled Tribe candidates to be paid along with the submission of application in the form of Demand draft payable at Visakhapatnam in favour of Indian Maritime University, Visakhapatnam campus.
- B. Upon confirmation of admission, the candidates are instructed to pay the following fee at the time of reporting to IMU, Visakhapatnam campus for formal registration.
- I. A Counselling fee of **Rs.10,000/-** through a Demand Draft in favour of Indian Maritime University, payable at Visakhapatnam.
  - II. **Rs.25,000/-** towards Programme Fee through Demand Draft in favour of Indian Maritime University, payable at **Chennai**.

- III. The Semester fee of **Rs.1,00,000/-** should be paid at the campus for 3<sup>rd</sup> semester fee on the day of registration through a Demand Draft in favour of Indian Maritime University, payable at Visakhapatnam.
- IV. A fee of **Rs.20,000/-** should be paid at the campus as caution deposit (refundable) through a Demand Draft in favour of Indian Maritime University, payable at Visakhapatnam.
- V. Balance fee for 2<sup>nd</sup> year **Rs.1,00,000/-** will be paid in the month of January 2021.
