 - iv) **The rates should be quoted in a detailed manner with Unit price, Discount rate, Vat/Tax applicable.** No advance payment will be made.
 - v) The Campus reserves the right to accept in part or in full any quotation(s) or reject any or more quotation(s) without assigning any reason or to cancel the tendering process and reject all quotation(s) at any time prior to award of contract, without incurring any liability, whatsoever to the affected bidder or bidder(s).
 - vi) The firm furnishing the quotation should be able to supply the stated quantity **within one month** of issue of Purchase Oder. Payment will be only after satisfactory delivery and inspection of gym items.
