CORRIGENDUM 1

Following Clause/Clarification is being issued with respect to the tender for comprehensive annual maintenance contract for hardware, software, network and facility management services at IMU- Visakhapatnam Campus and is based on the e-mail requests and discussions with the prospective bidders in the pre bid meeting held on 17th February 2020.

Clarifications/New Clause

- **1.** There is no change in the due date and time of submission of the tender.
- 2. The S.No of Firewall and analyzer Fortigate 500 is FG5H0E5818902467 and will enter into AMC from 1st July 2021. The same is to be taken into account in Annexure 7. Accordingly the Price Bid format for Part 2 (RSP-2, Part 2) is revised and enclosed. The Bidders are requested to submit the quotes for the items in the price bid in the formats provided (RSP-2 Part 1, Part 2 and Part 3) only.
- 3. Section 3 Clause 3.16 (b) is modified to read as follows: "Submission of EMD is mandatory for all bidders except from Micro and Small Enterprises (MSME) who are registered with

Ministry of Micro, small and medium enterprises in the area of computer consultancy and computer facility management activities. Such MSMES have to submit the certificate issued by the Ministry of Micro, small and medium enterprises. If the EMD/MSME certificate relevant to the tender is not enclosed the bid will be summarily rejected."

- 4. Section 4, Clause 4.2.2.2 (C) is modified as follows: 'In case of breakdown of items covered under warranty, and could not be replaced / repaired by OEM within the downtime period. The contractor should endeavour to arrange for repair with equivalent spares or provide an alternative equivalent system to the extent possible till such a time the issue is resolved by the University with the OEM. However penalty will not be levied under such conditions."
- 5. Section 4, Clause 4.2.2.2 (d) is modified as follows: "If the equipment warranty expires during the tenure of the contract, the same will be added to the list of equipment to be maintained by the contractor. The contractor shall provide maintenance services for such equipment as indicated in the price bid (RSP2 Part 2) from the date of expiry of warranty till the contract completion date".
- 6. Section 4 Clause 4.2.6 (e) is modified as follows: "If any new hardware and software procured the contractor should install, configure and provide support for installation of OS and liaise with the OEM for configuring the hardware /specialized software's."
- 7. Annexure 3 clause 2.3 is modified to read as "Contractor undertakes the responsibility to maintain trouble free services."
- 8. Annexure 3 clause 6.3 is modified to read as " If any equipment is defective at the time of entering this agreement, the same will be out of AMC. Post rectification of the defect by the University it will be included in the scope of the contractor".
- 9. Annexure 3 clause 6.8 is modified to read as "The contractor should provide preventive and corrective maintenance with the original spare parts of the OEM and within the time frame allowed for downtime. In case the system is to be repaired with parts other than original parts due to non-availability of original spare part, the IMUV representative before replacement should approve the alternative spare part."
- 10. Annexure 3 clause 12.1 is modified to read as "All disputes and differences of any kind, arising out of or in connection with this AGREEMENT, shall be resolved through an arbitrator appointed

a mutually agreed by both parties and the arbitration proceedings shall be conducted in accordance with the provisions of the Arbitration and Conciliation Act, 1996 or any statutory modifications or enactment thereof."
